Further Information sought has not been expressly forbidden to be published by any court of law or tribunal or the disclosure of which may constitute contempt of court. Hence it cannot be denied under section 8(1)(b) of RTI Act. Further, DOPT is the custodian of the information sought and hence information sought not be denied under section 8(1)(e) of RTI Act. Further there is a large public interest involved in disclosing the sought information and hence information sought information does not fall within the restrictions contained in Section 8 & 9 of the RTI Act
