Information may pl be furnished to me under Section 2 j of the RTI Act at the earliest without waiting for maximum time limit as the same is urgently required for making Urgent further Submissions in the Interest of Justice in connection with my Written Submissions/ subsequent Petitions / Appeals to Hon'ble MOEIT -the Disciplinary Authority and the Hon'ble MoS regarding - INVALID, Forged, Malafide Charge Memorandum No.1(01)/2019/DC-Vig. backdated as 28.01.2022 (being processed malafidely Ex-Parte in MeitY through e-File / computer file no. 3076882) issued without consulting UPSC thereby violating mandatory provision of article 320(3)(c) of the Constitution of India and further issual of two NIC Office Orders of same no. No. 1(01)/2019/DC-VIG backdated as 11/03/2022 illegally prematurely Ex-parte nominating IO / PO through this file and all the aforesaid after repeatedly putting up Ex-parte fabricated, forged Notings on e-files by highly prejudiced rather vindictive DG(NIC) & VO(NIC) , who have fabricated this forged case , in collusion with highly prejudiced/ Biased Personnel Division of MeitY after repeatedly "CONCEALING" & "NOT PUTTING UP ON FILE" TO THE DISCIPLINARY AUTHORITY – ALL MY WRITTEN SUBMISSIONS / SUBSEQUENT PETITIONS/ APPEALS ADDRESSED TO THE DISCIPLINARY AUTHORITY VIZ; HON'BLE MOEIT AND HON'BLE MOS(IT), *with malafide intentions to mislead/ misinform the Hon'ble MOEIT / Hon'ble MoS to take their Ex-parte approval by deception without perusal of my*

submissions and the aforesaid Forged Fabricated Notings were put up on e-file even after Concealing important facts about my Illegal, unauthorized, “malafide” Transfer dated 27 May 2017 from the post of HoD (Training), NIC Hqrs to a lower in status Non-HoD post outside NIC Hqrs (unauthorizedly made due to malafideby prejudiced DG, NIC in defiance of Supreme Court mandamus in case TSR Subramanian Vs UOI and in gross violation f DOPT OM Dated 2nd July 2015 to Misuse Training Platform for Vendor / Product promotion on single nomination basis in the grab of Technical Sessions and to keep making heavy unrequired expenditure on student like useless online Training with heavy expenditiure on licenses of Vidyakosh after stopping the high level Training which was being organized by me in my capacity as HOD(Trainng) at Govt Institires of International repute-the IIMs, the IITs as per National Training Policy with approval of earlier DGs and the then Secretary Shri J Satyanarayana and then the then AS Shri Rajeev Gauba (now Cabsec)) viz;

- (i) **after concealing the Orders dated 10/06/2017 of the then Secretary(MeitY) Ms Aruna Sundararajan cancelling my Transfer Order and restoring NIC Office Order dated 25/03/15 issued in compliance to CAT Order dated 05/03/15 (which CAT order had earlier restored my position as HOD(Training) after Quashing/Setting aside my earlier Transfer order from the post of HOD(Training) by DG, NIC as unauthrised and malafide & which order of CAT for my continuance as HOD(Training) was also upheld by Hon’ble Delhi High Court)**
- (ii) **after concealing the Stay Order granted by Hon’ble CAT dated 19.12.17 against my malafide, unauthorsed transfer from the post of HoD(Training)**
- (iii) **after Tampering my Leave account at a later date and rejecting through FORGERY by Admin I Section (may be in collusion with HoD, OA Division running Online Leave System) my Medical Leave for the period during which I was on rest advised by authorised Govt doctor which Medical Leave was already approved after submission of my Leave Application in hardcopy at the time of Joining after sickness on 10/04/19 to the then DG(NIC) Ms Neeta Verma alongwith Medical Certificate and subsequently Leave application Online alongwith**

Medical certificate as attachment ; such Tampering was done to fraudulently, lawlessly show the period as non-joining / absence

Not only this my Petitions/ Complaints submitted against Fabrication of this Forged case prior to issue of Charge Memorandum dated 28/01/2022 and then my Written submissions / subsequent Petitions/ Appeals for Quashing of Forged, Fabricated Charge Memorandum dated 28/01/2022 as well as for Quashing of Premature nomination of Biased person K S Raghavan as IO & then for Cancellation of nomination IO on ground of proven "Bias" by hurriedly proceeding and not "Staying" the proceeding but illegally proceeding in the matter in gross violation of DOPT OMs- all these Petitions of undersigned have been malafidely Concealed / Not put up "on file" for taking orders of the Disciplinary authority with malafide intentions to mislead/ misinform the Hon'ble MoS / Hon'ble MOEIT to take their Ex-parte approval against me by deception without perusal of my Submissions.

HENCE THE FOLLOWING INFORMATION MAY BE PROVIDED UNDER SECTION 2j OF THE RTI ACT immediately within 72 hours as the same is required for submitting immediate Petition to the Disciplinary Authority regarding aforesaid Fabricated, False , Forged Disp. Proceeding against me for non-joining after tampering my leave account, illegally withholding my salary , concealing Hon'ble CAT's Stay Order against transfer , which all is affecting my "Right to (dignified) Life" covered by Article 21 of the Constitution as explained by Hon'ble Supreme Court in its various judgements **because it has come to notice that - although the matter is seized with the Disciplinary Authority due to pendency of my aforesaid Written submissions/ Petitions with the Disciplinary Authority-Hon'ble MOEIT / Hon'ble MoS(IT) for Quashing the Forged, Fabricated, Invalid Charge Memorandum as well as Illegal, malafide, pre-mature nomination of IO - **yet in another attempt to mislead/ misinform the Secretary(MeitY) , Hon'ble MoS , Hon'ble MOEIT to take some approval against me by deception , again after CONCEALING my aforesaid correspondence,** the aforesaid EX-PARTE File No. 1(01)/2019/DC-VIG (e-File / Computer File No. 3076882) has been submitted by prejudiced VO(NIC) Mr IPS Sethi and highly prejudiced/ biased DG(NIC) Sh Rajesh Gera on 15/05/2023 through AS (Shri Amit Agrawal) to Personnel Division (MeitY) :-**

Rajeev Chandrasekhar, Secretary(MeitY) Shri Alkesh Kumar Sharma, AS&Group Head(NIC) Sh Amit Agrawal, DG(NIC) Sh Rajesh Gera *with specific ,most relevant request to DG for issuing directions to VO Sh I PS Sethi and IO Sh K S Raghavan for not fabricating records and not proceeding further with the Inquiry in gross violation of DOPT Rules (pl refer specific Rules as quoted in the subject above) & after diluting the authority of the Disciplinary Authority when the whole issue / my Petitions are pending with the Disciplinary Authority for Quashing the Forged, Fabricated Charge memorandum as also the Illegal, pre-mature nomination of IO.*

the Hon'ble MOEIT/ Hon'ble MoS in the above (and other) Quasi-Judicial Disciplinary matters by the Personnel Division of MeitY in collusion with DG(NIC) / VO (NIC) falsely mentioning therein that I have not submitted any reply to Charge memorandum thereby misleading /misinforming the Disciplinary Authority -the Hon'ble MOEIT / Hon'ble MoS to take their approval by deception for furtherance of illegal, malafide, Invalid Disciplinary action against me (as has happened in another forged, fabricated, Invalid Disciplinary proceedings falsely charging me for "bypassing channel" in which UPSC opinion (even which was obtained by sending Ex-parte note to UPSC after obstructing me through tampering of my email from submitting my reply to forged charge memorandum) **was illegally withheld/ concealed from me for 16.5 months and then incomplete Opinion provided** and in which case even RTI information in response to my RTI application dated 23.06.2022 was provided to me on 15.02.2023 **after about 08 months** by CPIO(P-III), MeitY and even that may have been provided when some examination of files might have started at higher level after personal audience given to me on 25.01.2023 by judicious present Secretary, MeitY)
