Subject: Filling up the post of Director General, Indian Computer Emergency Response Team (DG, ICERT), at New Delhi in the HAG scale i.e. Rs.67000-79000/- regarding.

To enhance the security of Communication and Information infrastructure through proactive action and effective collaboration, the Central Government has set up Indian Computer Emergency Response Team (ICERT) in accordance with sub-section (1) of section 70B of The Information Technology Act 2000 as amended till date. The purpose of ICERT is, to become the nation's most trusted referral agency for responding to computer security incidents as and when they occur and also assist in implementing proactive measures to reduce the risks of computer security incidents.

2. It is proposed to fill up the post of Director General, Indian Computer Emergency Response Team (DG, ICERT) as per provisions of The Information Technology Act, 2000 as amended till date. The eligibility criteria, terms of office, salary & allowances and other conditions of service of the post of Director General, ICERT, are as under:

A. Eligibility Criteria:

Educational Qualifications and Experience:

- (i) Doctorate in Science/Engineering and fifteen years experience out of which five years should be at senior management level in Information Technology (IT) or related sectors; or
 - (b) Master's Degree in Science or Engineering or Technology and eighteen years experience out of which five years should be at senior management level in Information Technology (IT) or related sectors; or
 - (c) Bachelor's Degree in Engineering or Technology and twenty years experience out of which five years should be at senior management level in Information Technology (IT) or related sectors; and
- (ii) A minimum of two years experience in the area of cyber security, guiding teams in handling cyber security incidents, interface with information security auditors and other security agencies.

B. Terms of service:

The Director General shall hold office for a period of five years, and shall be eligible for re-appointment until he attains the age of sixty-five (65) years.

C. Pay & allowances and other conditions of service:

The Director General shall be paid the pay and allowances as admissible to an Additional Secretary to the Government of India including all the benefits that an Additional Secretary is entitled to.

Provided that the pay and allowances of such a Director General shall be reduced by gross amount of pension and pension equivalent of gratuity or employer's contribution to the Contributory Provident Fund or any other form of retirement benefits, if any, drawn by him.

D. Provident Fund:

The Director General, ICERT, shall be governed by the provision of the Contributory Provident Fund (India) Rules, 1962 and is not entitled to subscribe under General Provident Fund.

E. Pension:

The Director General shall be deemed to have retired from Govt. service upon taking up respective appointment in the ICERT and not entitled for any pension and gratuity for the service rendered in the ICERT.

- Eligible and interested persons may submit their applications in the prescribed format (Annexure-I) along with attested copies of certificates relating to qualifications, date of birth etc. to Shri Girish Sahai, Joint Director (Pers.), Department of Electronics and Information Technology, 'Electronics Niketan', 6, CGO Complex, New Delhi-110003, within 45 days from the date of publication of advertisement in the Employment News. 10 more days shall be given in respect of applications received from the candidates residing in remote areas viz. Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh Division of Jammu and Kashmir State, Lahual and Spiti District and Pangi Sub-division of Chamba District of Himachal Pradesh, the Union Territory of Andaman and Nicobar Islands or the Union Territory of Lakshadweep. Those who are working in the Central/State Government may send their application through proper channel along with photocopies of the ACRs/APARs of the last five years duly attested by an officer not below the rank of Under Secretary or equivalent. forwarding the application, it may please be verified and certified that the particulars furnished by the officer(s) are correct and that no disciplinary proceedings or vigilance case is either pending or contemplated against the officer. The integrity of the officer may also be certified by an officer of the rank of Under Secretary or equivalent that no minor/major penalty has been imposed on him. It may also be confirmed that in the event of selection, the officer concerned will be relieved of his/her duties.

Applications, which are incomplete or are not accompanied with the photocopies of ACRs/APARs for the last five years and other relevant documents in support of age, educational qualifications and experiences etc. will not be entertained and would be summarily rejected without any further correspondence.
