The significant developments pertaining to Ministry of Electronics and Information Technology for the month of June, 2021are as given below:

I. Important Policy decisions taken and major achievements during the month:

1. Digital Payments

During June, 2021, BHIM-UPI has continued to show upward trend by recording over 280 crore transactions, with value of Rs 5.47 lakh crore, in the month of June 2021 which indicates the increasing acceptance of BHIM UPI as the preferred mode for making digital payment transactions.

2. International Cooperation

MeitY represented India in Fourth G20 Digital Economy Task Force (DETF) meeting under the Italia Presidency held on 16-17 June, 2021 on virtual mode. India shared country's position on various ICT issues including Digital transformation in production for sustainable growth, Measurement, practice and impact of the digital economy, Connectivity and social inclusion, Free flow of data with trust and cross-border data flows within domestically applicable legal frameworks, Leveraging trustworthy AI to include MSMEs, Consumer protection, Child protection, Smart cities, Blockchain for traceability of products and services, Digital tools to maintain public service and business continuity, Digital identity and Agile regulation.

India raised concern over the text on "data free flow with trust" and suggested to include the agreed text by the G20 leaders under the precious presidencies. India/ MeitY also suggested to discuss the issues under the priority area Consumers' Awareness and Protection, and Blockchain in Global Value Chains of Consumer Goods" in a different and relevant working group.

A webinar on ICT Cooperation between India and Vietnam in the context of COVID-19 pandemic was organized by the Embassy of India, Hanoi on 29th June, 2021.During the event, both sides discussed on various ICT schemes and emerging technologies. Representative of MeitY delivered a Key Note address on the topic 'Sustainable Digital Platform for India'.

MeitY and MEA represented India in Shanghai Cooperation Organisation (SCO) Experts meeting on the Concept of Pool of TechnoParks held on 30th June, 2021 on virtual mode. India presented country's position on various issues related to cooperation on TechnoParks and Innovation Clusters amongst the SCO members. India suggested to limit the scope of organization structure of the concept at B2B level only and once finalized, the Special Working Group on modern information and telecommunication technologies may be requested to take this concept forward.

3. National Informatics Centre

Aarogya Setu – Aarogya Setu is a mobile application launched to aid the COVID-19 efforts of the Government. The App augments the COVID-19 initiatives of the Government in proactively reaching out and informing the users of the app regarding risks, best practices and relevant advisories pertaining to the containment of COVID-19. More than 19.52 crore users have downloaded Aarogya Setu App till June, 2021.

4. UIDAI

UIDAI has been organizing a number of workshops regarding "Aadhaar Authentication and Offline Verification" explaining Online Authentication, Aadhaar Offline Verification, Aadhaar Paperless Offline e-KYC and Secure QR code and also give live demo of applications and services. During the month of June 2021, one workshop was conducted over Video Conference (VC) for various Central/State Government entities.

I. Important Policy decisions taken and major achievements during the month:

1. Digital Payments

During May, 2021, BHIM UPI has reported 254 crore number of digital payment transactions with a value of more than Rs. 4.91 lakh crore. In the FY 20-21, 5554 crore (provisional data) number of Digital payment transactions have been reported against the 4572 crore digital payment transactions during FY year 2019-20 depicting the growth of 21.48%.

2. International Cooperation

i) Signing of the new India-UK Joint Declaration of Intent on Digital and Technology

On 4th May 2021, a Virtual Summit was held between Prime Minister of India and the Prime Minister of the United Kingdom under India and UK Strategic Partnership. During the summit, the *signing of the new India-UK Joint Declaration of Intent (JDI) on Digital and Technology was welcomed.* The JDI is to facilitate and encourage cooperation between the countries' industries in the ICT sector.

ii) India-EU technological cooperation on Quantum and High Performance Computing (HPC)

During the India-EU Summit held on May 8, 2021, it was agreed to deepen technological cooperation on Quantum and High Performance Computing (HPC).

The virtual meeting was held to explore, identify and agree to the main areas of our future cooperation and to discuss the framework for such possible collaboration in HPC and its applications on COVID-19 as well as on climate change/extreme weather events.

Both sides shared the progress and best practices made by them in the field of High Performance Computing and decided to continue to interact with each other and schedule the joint workshops, training, exchange best practices and explore ways to have a joint-research mechanism in the field of HPC.

iii) Third G20 Digital Economy Task Force (DETF) meeting

India was invited to the Third G20 Digital Economy Task Force (DETF) meeting under the Italia Presidency held on May 17-18, 2021 on virtual mode. MeitY along with MEA officials represented the country and shared country position on Zero draft of digital economy ministerial declaration and its Annexes/ Report on various ICT issues including Digital transformation in production for sustainable growth, Measurement, practice and impact of the digital economy, Connectivity and social inclusion, Free flow of data with trust and cross-border data flows, Leveraging trustworthy AI to include MSMEs, Consumer protection, Child protection, Smart cities, Block chain for traceability of products and services, Digital tools to maintain public service and business continuity, Digital identity and Agile regulation.
