Ministry of Electronics and Information Technology Major achievements for the month of December, 2022

The significant achievements pertaining to Ministry of Electronics and Information Technology for the month of December, 2022 are as given below:

1. Digital Payments

During December 2022, BHIM-UPI has continued to show upward trend by recording over 782.95 crore transactions, with value of Rs 12.82 lakh crore, in comparison to 730.95 crore transactions, with value of Rs 11.91 lakh crore in November. It indicates the increasing adoption of BHIM-UPI as the preferred mode for making digital payments amongst the citizens.

2. Electronics Manufacturing

(i) Production Linked Incentive Scheme (PLI) for Large Scale Electronics Manufacturing(LSEM) of Mobile Phones and Specified Electronic Components

During December, total incentive amounting Rs 415.46 crore has been disbursed under PLI Scheme for LSEM to two companies. Empowered Committee (EC) in its meeting convened on 30.12.2022, has also recommended for disbursement of Incentive Claim of Rs. 411.07 Crore to M/s United Telelinks Neolyncs Private Limited and M/s Wistron Infocomm Manufacturing (India) Private Limited for FY 2021-22.

(ii) Production Linked Incentive Scheme (PLI) for IT Hardware

Incentive amount of Rs 5.30 crore has been disbursed to M/s Bhagwati Pvt Limited, an applicant under domestic category of PLI Scheme for IT Hardware, for performance during FY-21-22.

(iii) Modified Special Incentives Package Scheme (MSIPS):

3 Applications, namely, LG Electronics India Private Limited (Phase-II), Desai Electronics Private Limited (phase-II) and GE BE Private Limited (Phase-III) have been approved in the month of December, 2022 with total incentives of Rs. 18.35 crore. In addition, 7 proposals have also been recommended in 69th AC meeting of MSIPS.

(iv)Electronics Manufacturing Clusters (EMC) Scheme:

An amount of Rs. 6.09 crore has been released to M/s Deogiri Electronic Cluster Pvt. Ltd. (DECPL) towards Common Facility Centre (CFC) at Shendra Industrial Area, Aurangabad, Maharashtra.

(v) Electronics Manufacturing Clusters (EMC 2.0) Scheme: An application for setting up of Common Facility Centre at Hyderabad, Rangareddy, telangana has been submitted by T Works Foundation on 08.12.2022 with a project cost of Rs. 105.56 crore seeking financial assistance of Rs. 75 crore from MeitY.

3. UIDAI

Aadhaar Authentication transactions increased from 195.39 crore in November 2022 to 208.47 crore in December 2022 while e-KYC transactions increased from 28.75 crore in November 2022 to 32.49 crore in December 2022. For providing convenient Aadhaar enrolment and update services to the people, 88 Aadhaar Seva Kendras(ASKs) covering 72 cities (open 7 days of the week except public holidays) have been made operational across the country as on December, 2022.

4. Minimum Government, Maximum Governance

- (i) Jeevan Pramaan: Since inception, total 6.9 Crore Digital Life Certificates
 (DLCs) have been generated. 11.86 lakh DLCs have been generated in the month of December, 2022.
- (ii) MyGov: Till December, 2022, MyGov has 967 discussion themes and 1341 tasks. Around 2.9 crore people have registered on the Platform.
- (iii) Open Government Data Platform (OGD) India: Till December, 2022, around 5.93 lakh resources have been contributed under 12,940 catalogs and 2,831 Visualizations and 1.75 lakh APIs have been created. Approx 95 lakh datasets have been downloaded.
