

**Ministry of Electronics and Information Technology**  
**Monthly Achievements for the month of August, 2023**

The significant developments pertaining to Ministry of Electronics and Information Technology for the month of August, 2023 are as given below:

**1. Electronics Manufacturing**

**(i) Development of Semiconductors and Display Manufacturing Ecosystem in India**

A total of forty-two (42) applications have been received under the Programme for Development of Semiconductors and Display Manufacturing Ecosystem in India. This includes five (5) applications for setting up semiconductor Fabs in India, two (2) applications for setting up Display Fabs in India, eight (8) applications for setting up compound and ATMP facilities in India, and twenty-seven (27) applications for the Design Linked Incentive Scheme.

Seven (7) applications have been approved under the ATMP scheme.

**(ii) Scheme for Promotion of Manufacturing of Electronic Components and Semiconductors (SPECS)**

- As on August 2023, 36 applications have been approved with proposed investment of ₹ 11,429 crore and committed incentive of ₹ 1,562 crore.
- As on August 2023, ₹ 251.53 crore has been disbursed to (06) applicants.

**(iii) Modified Special Incentives Package Scheme (MSIPS)**

- As on 31 August, 2023, 320 applications with proposed investment of ₹ 86,005 crore are under consideration. Out of these 320 applications, 316 applications with proposed investment of approximately ₹ 83,748 crores have been approved, 2 applications with proposed investment of approximately ₹ 164 crores have been recommended by the Appraisal Committee for approval, 2 applications with proposed investment of ₹ 2,093 crore are under appraisal.
- As on 31 August, 2023, incentives of ₹ 2191.46 crore have been released to 130 applicants under MSIPS.

- Under this scheme, approval letter was issued to LG Electronics India Pvt Ltd (phase-II)- Pune and Noida unit on 07 August, 2023 with a proposed investment of ₹ 239.33 crore and ₹ 324.21 crore and committed incentive of ₹ 49.96 crore and ₹ 62.47 crore respectively.
- **Production-Linked Incentive (PLI) Scheme 2.0 for IT Hardware** The application window was closed on 30.08.2023. The scheme received 40 applications.

## 2. Pradhan Mantri Gramin Digital Saksharta Abhiyan (PMGDISHA)

As on 31<sup>st</sup> August 2023, ₹ 1800.50 crore has been released to CSC-SPV for implementation of the Scheme. A total of around 7.09 crore candidates have been enrolled and 6.13 crore have been trained, out of which 4.57 crore candidates have been certified under the PMGDISHA Scheme.

## 3. Minimum Government, Maximum Governance

- (i) **Jeevan Pramaan:** A total of 2,86,257 Digital Life Certificates (DLCs) have been generated in the month of August 2023.
- (ii) **MyGov:** Till August 2023, MyGov has 988 discussion themes and 1470 tasks. Around 3.27 crore people have registered on the Platform.
- (iii) **Open Government Data Platform (OGD) India:** Till August 2023, more than 6.11 lakh resources have been contributed under 13,058 catalogs and 2,992 Visualizations and 1,96,992 data sets APIs have been created. 97.83 lakh datasets have been downloaded.
