Official press release of the Cabinet Secretariat had stated that most decisions in this area had already been taken. Information relating to the said Cabinet Committee, previously exempt from disclosure under 8(1)(i) of the RTI Act, would then have moved in some part into the purview of the proviso to said section that mandates the information to be made public. PLEASE INFORM the manner in which, by mandate of proviso to section 8(1)(i) of the RTI Act, information related to the Cabinet Committee on Unique Identification Authority of India has been made public after its winding up. In particular:</p> <p>a) If the information has been made public via the internet, please inform the exact URLs, or</p> <p>b) If the information has been made public only to extent of becoming accessible under section 6 of the RTI Act, to enable duly informed resort to section 6 please provide complete description of the records related the Cabinet Committee.</p> <p>PLEASE NOTE: I had requested information in this regard from Cabinet Secretariat. Decision on my</p>	<p>The information sought by you is not clear.</p> <p>However, Please refer Para-10 of the Guide on the Right to Information Act, 2005 circulated vide Department of Personnel and Training OM No. 1/32/2013-IR dated 28/11/2013 which inter-alia states that "The Public Information Officer is not supposed to create information; or to interpret information; or to solve the problems raised by the applicants; or to furnish replies to hypothetical questions". Part I (Para 14) of the same guide states that "the Public Information Officer is required to supply the 'material' in the form as held by the public authority, but not to do research on behalf of the citizen to deduce anything from the material and then supply it to him". such information is available.</p>

appeal in respect of the Transfer explained that the decision as to whether a matter is complete or over is of the concerned Department. NITI Aayog CPIO informed that the information does not concern the particular vertical. Decision on my appeal for response on behalf of all of NITI Aayog confirmed that the information does not concern NITI Aayog because UIDAI is no longer attached to it. From the Allocation of Business Rules published on Cabinet Secretariat website I ascertained that UIDAI is attached office of MEITY. Hence now this request is addressed to MEITY CPIO.
