**General Terms & Conditions:**

1. Candidates working in Central/ State Government/ PSUs/ Autonomous organizations may submit a copy of NOC issued from their organization at the time of applying online or till the last date of receipt of application.
2. Immediate Absorption rule shall be applicable as per Govt. extant rules.
3. Appointment made on Absorption basis from lower post/ Direct Recruitment basis shall be on probation period of two years which is likely to be regularized/ extended/ terminated depending upon the performance of the candidate during probation period.
4. Candidates who have applied on Absorption/ Deputation basis are requested to provide the necessary documents along with document certifying the date of appointment in the present grade/ lower grade.
5. With a view to having uniformity in screening of the applications, an equivalency of CDA Pay Scale vis-a'-vis IDA Pay Scale is applicable in this organization is enclosed at Annexure-'A'.
6. The period of Deputation initially shall be for a period of 03 years.
7. The candidates evaluated on the basis of CGPA or else method shall have to provide in writing exact Division from concerned University.
8. Age shall be reckoned as on last date of receipt of online application (i.e., 30.12.2024). The upper age limit in respect of candidates working in Govt./STPI on regular basis or candidates belonging to Scheduled Castes, Scheduled Tribes, Other Backward Classes and persons with disabilities shall be relaxable as per prevailing instructions. Relaxation in the upper age limit shall also be provided to the contract employees engaged by STPI on consolidated monthly remuneration equivalent to the period of their continuous service performed in STPI, which shall not exceed five years.
9. The eligibility of the candidates in terms of educational qualifications, experience, age etc. will be determined on the information furnished by the candidate on the closing date for receipt of online applications. No adding information shall be entertained after the closing date of receipt of online applications. Incomplete online applications will not be entertained.
10. The number of posts may vary. STPI reserves the right not to fill up any of posts, if it so decides. STPI reserves the right to operate the post(s) of higher grade in the lower grade and to offer the appointment to the candidate in lower grade, in case the Selection Committee recommends. However, candidates may bargain for additional increment for pay fixation/ Pay protection.
11. Management reserves the right to fix the criteria for short listing the candidates to be called for interview.
12. In case any candidate found ineligible on any grounds even after his appointment, his service will be terminated immediately without assigning any reason thereof. Candidates are warned that they should not furnish any false/misleading information/document or submit any document which is defective or fabricated or otherwise commit any act of misconduct in submitting the application form or during the course of recruitment. In case any such case is detected by STPI at any stage, during or after recruitment OR in case any candidate found ineligible on any ground, appropriate action shall be taken against the candidate.
