Inputs (i) & (ii): IT for Masses Programme under Manpower Development scheme of Digital India Programme (umbrella scheme) is aimed at narrowing the Digital Divide by initiating/promoting activities in ICT for focus groups (Women, Scheduled Caste, Scheduled Tribe, Senior Citizen, Differently Abled & Economic Weaker Section (EWS) and underprivileged areas (North Eastern Region, Backward Districts and Blocks & Districts having more than 40% SC/ST population) for inclusive growth of IT Sectors through Infrastructure Creation, Training, Capacity Building & Entrepreneurship Creation activities in IT domain.

Under the aforesaid programme, a project "Capacity Building to Enhance the Employability of the Engineering Graduates in Emerging Technologies" is being implemented by the Vellore Institute of Technology (Deemed to be a university under the Section 3 of the University Grants Commission Act, 1956) with an aim to train 2000 SC/ST graduates/graduands, industry workers, IT professionals and academicians in IECT and associated technologies like data science and analytics, Artificial Intelligence (AI) & Machine Learning, software development and cybersecurity, with the help of skilled technocrats from the software industry and expert Professors. The theme is to create a well-trained workforce, with good adaptive capabilities - professionals and tutors, through learning by doing in the IECT domain.
