Fee Reimbursement to SC/ST candidates

As per the directions received from Planning Commission through MeitY (then DeitY) Vide their communication No.D.O.No.M-13054/2/2005-BC dated 05.09.07, NIELIT is implementing the Scheduled Caste Sub Plan (SCSP) for Scheduled Castes and Tribal Sub-Plan (TSP) for Scheduled Tribes since 2007-08. According to the directions and guidelines for implementing the scheme, no fee should be charged from the SC and ST candidates for educational and skill development programmes by the Government and autonomous institutions and the expenditure for the Scheme should be accounted for from the SCSP and TSP fund of the respective Ministries /Departments. Under this scheme, NIELIT Centres do not charge fees from the SC or ST candidates for undergoing courses offered by NIELIT. Further, there is no exclusive batch/schedule of training under this scheme and the beneficiaries are trained as per general training schedule of the respective NIELIT Centre.
